

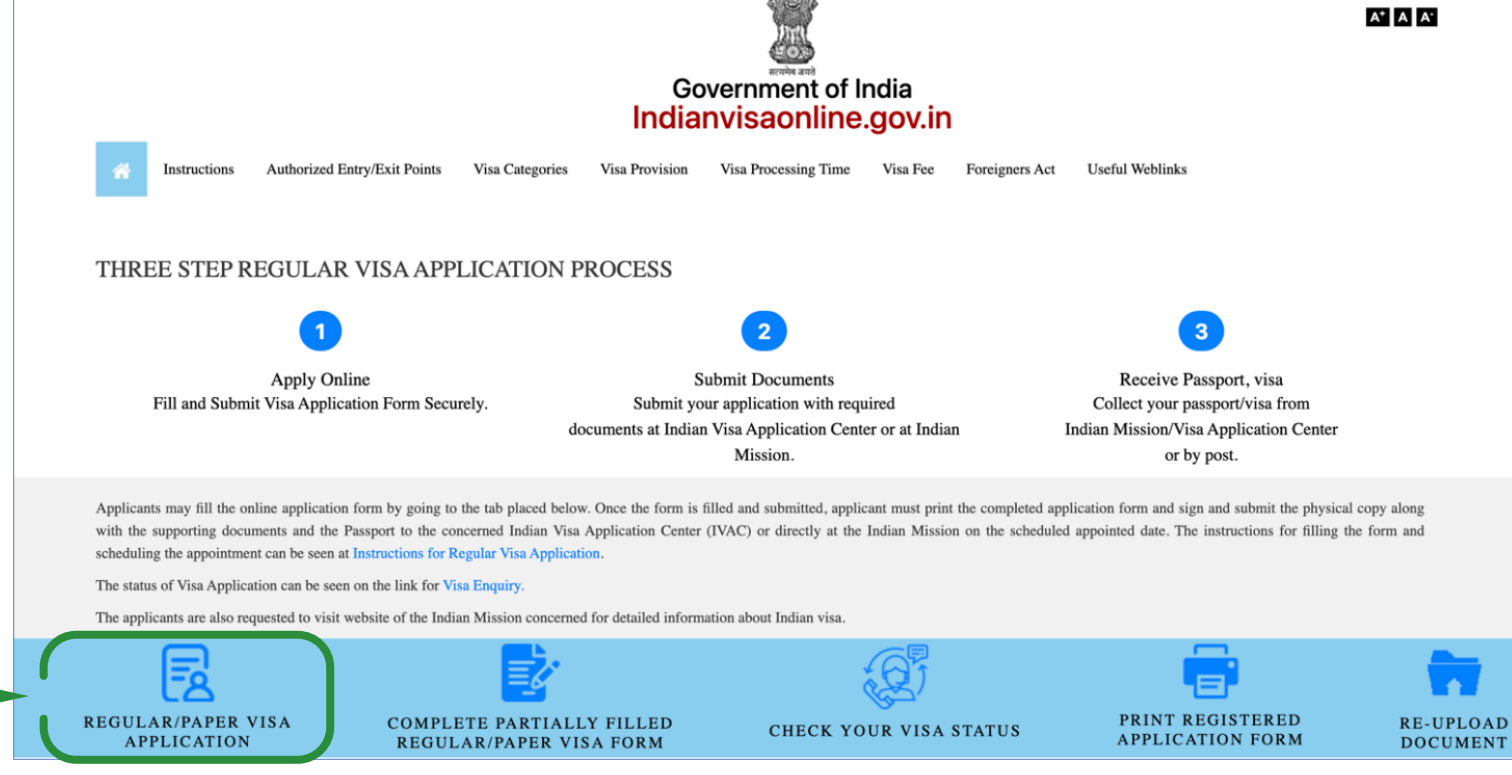
Application process for Medical Visa to India from KSA for Saudi Nationals/ Residents

Step 1 Visit <http://indianvisaonline.gov.in/>

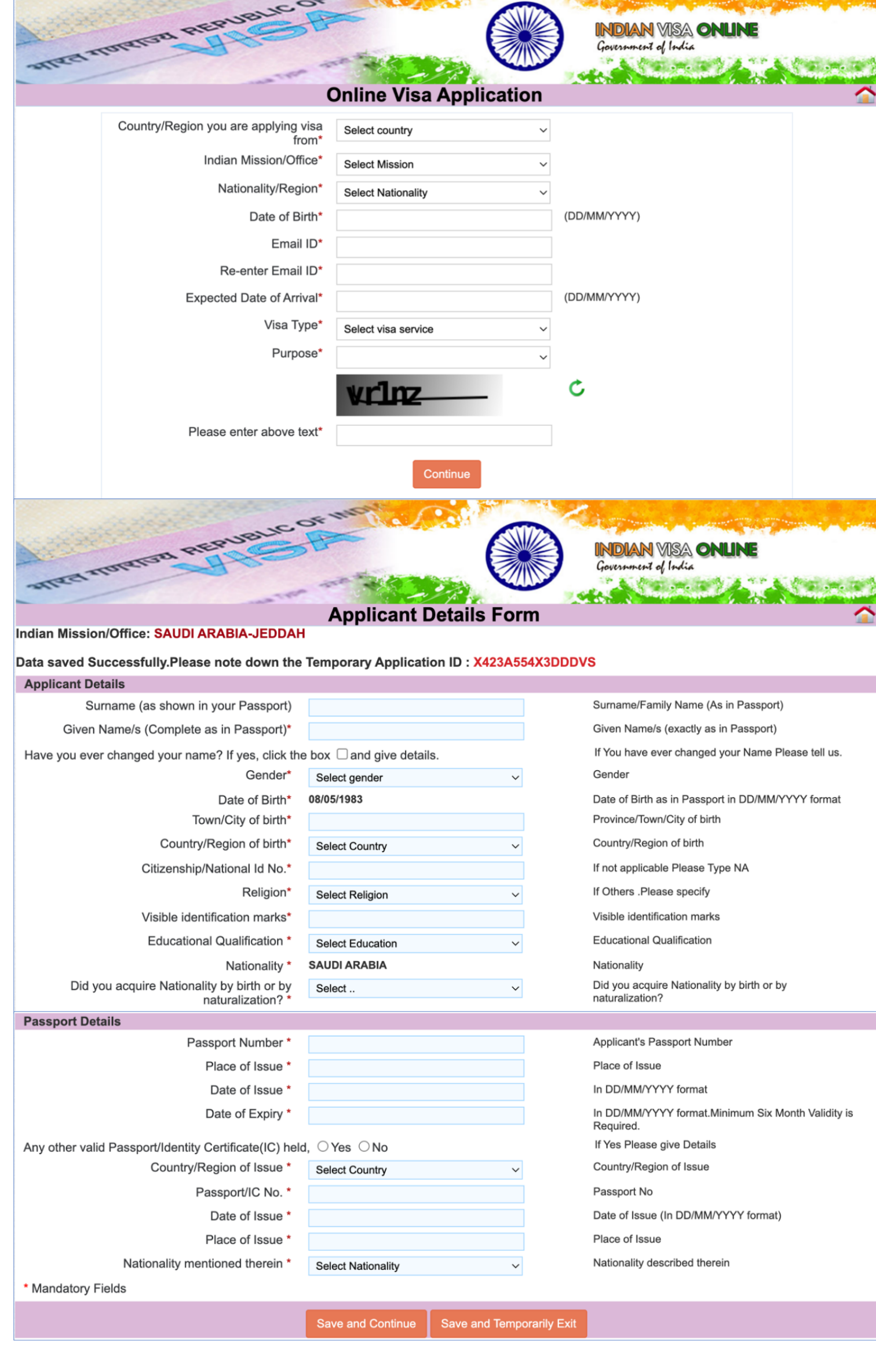
Step 2 Select option “For Regular/Paper visa by Indian Mission/Post”



Step 3 Select “Regular /Paper Visa Application”



Step 4 Fill in the application form and click **Continue**.
Note down the application number for future reference.



Step 5 Take print out of the application.

Step 6 Visit Consulate General of India – Jeddah – Visa section

Step 7 Meet Visa Section officer and submit the following documents

- Duly completed online application form
- Passport with copy (valid for a minimum period of Six months at the time of submission of visa application)
- Two passport size photographs
- Iqama/Saudi National ID with copy
- Medical report from Saudi Hospital
- Visa Invitation Letter from the Hospital in India. It should be received at the official email IDs of the consulate mentioned below;
visa.jeddah@mea.gov.in, cons.jeddah@mea.gov.in
- National address proof printout
- Confirmed air ticket

Step 8 Once approved by Visa Section, visit VFS Center for submission of application & biometrics.

FAQs

- How many companions or bystanders are allowed to accompany the patient?
a. 2 attendants are allowed to accompany the patient depending on exigency. Each one has to submit a separate application form. Visa type can be selected for medical attendants in the visa type section
- What is the maximum duration for medical visa?
a. Depending on medical exigency.
- What if I need an air ambulance for shifting?
a. You will have to coordinate with airline services for that
- What if the patient is too sick to visit the embassy and VFS center?
a. Recommendation letter from the hospital certifying patient's medical condition to be submitted along with the application.
- What is the visa charge?

Sl.	Description	Fees (SR)
1.	Medical/Medical Attendant Visas - Valid upto 6 months from date of issue (Single or Multiple)	313 + service charges
2.	Medical/Medical Attendant Visas - Valid for more than 6 months and upto 1 year from date of issue (Multiple)	463 + service charges
